II. Assessment Update

- A. Cindy Kazanis & Keric Ashley
 - a. Update on Dashboard --
 - i. CDE has put out one page handouts, including a what's new page. List of schools in a district has been added. (County list in 2018 fall)
 - ii. ELI Indicators allows user to click to see status and change.
 - iii. College and Career Indicator (academic performance) is based on 2017 data, 2018 cohort). Assessment Performance results reflect # of students at or above proficiency. Goal is for next Fall the CCI will reflect the current cohort.
 - iv. Using proficiency (not district to level three) Suggestion: list on a separate page/tab and add subgroups
 - v. Detailed reports tab: Class of 2016. New set of bar graphs. Connects to CDE reports & data. Shows who is in the cohort, what criteria/**measure** met the CCI expectation by subgroups for prepared and approaching prepared. Excludes students enrolled in alternative education.
 - vi. Memo forthcoming (next month) on updates and things that will be added to CCI in the Fall.
 - vii. Under Academic Indicator -- added information on English Only for Math and ELA as well as Alternative Assessment data.
 - viii. Chronic Absenteeism reporting on dashboard is scheduled to go to the board in March. Once board approves calculation, a private preview will follow.
 - ix. Mobil app is still in progress. Budget includes user interface.

- b. ESSA Update
 - i. CDE will return to provide some sub-group data on indicators, looking at number of schools identified for support.
 - ii. Board took action on all other items identified by the federal review. The only issue that is still in progress is the methodology for the
 - iii. Identification of Districts for LCFF Support based on Multiple Criteria:
 - 1. LCFF -- Criteria outlined for Differentiated Assistance.
 - 2. Baseline -- All state indicators red or all state indicators red and 1 orange.
 - 3. Graduation Rate - Any high school that receives a graduation rate below 67% for three consecutive years.
 - 4. Expanded -- other colors (state unlikely to go in this direction as too many schools are identified based on the methodologies above 1-3).

 - Keeping focus on “seeing the system” and not jumping to solutions. Developing shared understanding about why this is important.
