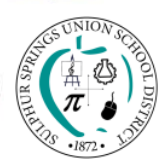
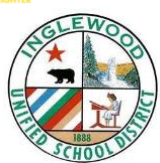
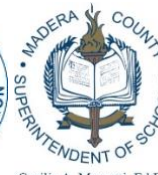
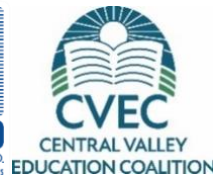
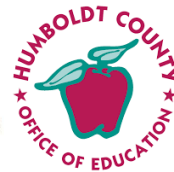


# FLOOR ALERT - SUPPORT SB/AB 86

Members of the Legislature:

On behalf of the undersigned groups representing public school agencies, we are pleased to express our support for SB 86 / AB 86, as amended March 1, 2021. The amendments to the bill go a long way to addressing nearly all of our concerns, particularly those related to collective bargaining, testing cadences, timelines and timing. This plan prioritizes our state's most vulnerable students, bringing them one step closer to safely returning to the learning communities entrusted with their care.

We also want to express our sincere appreciation to the excellent staffs of the two houses and the Administration for the hard work they put into crafting a compromise on this important issue.

We urge all members of the Legislature to support this compromise, as it will provide needed resources to keep schools that are delivering in-person instruction open, and to more quickly open schools to in-person instruction in California.
