### **March 2021 Board of Directors Meeting Highlights**

### **System of Support**

Judy Flores (Shasta), Jennifer Hicks, Assistant Superintendent of Educational Services, Placer County, Rachael Maves, Deputy Superintendent of Public Instruction, Instruction & Measurement Branch, CDE, Karen Stapf-Walters provided a review of the recent all leads meeting for the system of support. The group discussed the importance of reimagining the use of data to enhance the response to the needs of students during this time and how to best keep lines of communications open among county superintendents and geo leads.

## **Strategic Planning**

Fern Tiger, Fern Tiger Associates, provided an update on the strategic planning project and next steps for the May strategic planning committee meeting.
