9:15-9:45	 Legislative and Budget/CCSESA Report Derick Lennox, CCSESA: Derick thanked the group for forwarding information on current bills, etc. Derick reviewed the AB 1316 Fact Sheet – Nonclassroom Based Charter School and Independent Study Reform A moratorium created as a response to large scale fraud by a number of nonclassroom-based charter schools. 2022-23 school year will have a single set of criteria for Independent Study including frequency of teacher and student contact, mode of communication (inperson, visual, over the phone, etc.), requirement to offer an in-person option to students with exceptional needs and struggling students Funding is determined based on the amount of in-classroom instruction provided to the students. Have seen problems in over-reporting student attendance – CDE will be required to look at possibly connecting CALPADS with the state's attendance accounting system. 				

For small school districts: Districts with less than 2,500 in ADA can authorize NCB

charters up to 100% of district ADA.

- Districts of 2,500-5,000 ADA up to 2,500 ADA

JCCASAC – Jason Hasty, LACOE and Pam Coronado, Fresno CSS - Jason gave an update on the upcoming 51st Annual 2021 JCCASAC Virtual Conference. He stated that they were well prepared, and everything was ready to go. Keynote speakers include Debra Duardo (Los Angeles County Superintendent of Schools), Keith Johnson (Founder of Falcons Youth and Family Service), and Ami Davis (Founder and CEO of The Acadami).

10:00-11:00 Alternative Dashboard Update: Jenny Singh, CDE and Betty Miura, CDE

- Jenny and Betty presented the Update on Accountability and Dashboard Alternative School Status (DASS) presentation
- Department of Education letter in October, 2020, stated that using modified methods to calculate state indicators for DASS schools is not permissible under the ESSA.
- January, 2021 Amended ESSA State Plan includes DASS status cut scores for the academic indicator and DASS one year graduation rate.
- Plan submitted to ED for review and approval if not approved, a waiver will be requested.
- March, 2021 -- ED released the Accountability Waiver Template:
 - Removes 95% participation rate penalty
 - Removes requirement to ID schools for support based on 20-21 data
 - Requires schools currently receiving support to continue to receive support in 21-22 year.
 - Allows states to exit CSI schools based on graduation rate
 - States resume the ID of schools based on 21-22 data
- April 2021, ED approved waiver for accountability and reporting requirements
- 2020-21 accountability at local level still including
 - LCAPs
 - SARCs
 - DataQuest
 - Modified Dashboard Reporting
- Future Dashboard Reporting for 2021: Data that will help LEA's complete their LCAPs. For 2022: Current plan is to produce only Status to ID schools for support. For 2023: Status, Change and Performance colors.
- Alternative Schools Task Force: Positive Transition Rate may include students enrolling in a community college, joining military, etc.
- Alternative Schools Task Force requested a modified method be developed for the participation rate - can't meet the 95% participation rate target.
- Modified participation rate student must be enrolled for 90 days any time during the school year - 20 days within testing window.
- New Career Measures in the CCI State and Federal Job Programs, Pre-Apprenticeships and Transition Work-Based Experience and Transition Classroom Based Work Exploration - data collected in all 3 areas.
- Feedback from CCSESA SPSSC DASS schools in small and mid-size counties are struggling to make progress in the CCI.
- Discussion on challenges.

Summary: Current law establishes a public school financing system that requires state funding for county superintendents of schools, school districts, and charter schools to be calculated pursuant to a local control funding formula, as specified. Current law requires average daily attendance generated by certain pupils enrolled in a transitional kindergarten program to be included in the average daily attendance generated by pupils in kindergarten. Current law defines transitional kindergarten as the first year of a 2-year kindergarten program that uses a modified kindergarten curriculum that is age and developmentally appropriate. This bill would, commencing with the 2022–23 fiscal year, require the Superintendent of Public Instruction to compute an additional adjustment to the kindergarten and grades 1 to 3, inclusive, base grant, adjusted as described above, that is equal to 14.2% for each transitional kindergarten pupil who is enrolled in the school district or charter school that meets certain conditions, as specified.

Summary: Under current state law, public schools, including charter schools, and county offices of education are required to immediately enroll a homeless child or youth seeking enrollment, except as specified. Current law requires a local educational agency liaison for homeless children and youths to ensure that public notice of the educational rights of homeless children and youths is disseminated in schools within the liaison's local educational agency that provide services pursuant to the act. This bill would require a local educational agency to ensure that each school within the local educational agency identifies all homeless children and youths and unaccompanied youths, as defined, enrolled at the school.

Summary: Would require a local educational agency, on or before June 1,2022, to review and update its policy on pupil suicide prevention, and revise its training materials, to incorporate best practices identified by the department in the department's model policy. The bill would require a local educational agency, commencing with the 2022–23 school year, to provide suicide awareness and prevention training, at the beginning of each school year, to teachers of pupils in all of the grades served by the local educational agency. By imposing additional duties on local educational agencies, the bill would impose a state-mandated local program.

Summary: Current law requires the Superintendent of Public Instruction to establish a fee schedule for families using preschool and childcare and development services, as specified, and requires family fees, not to exceed 10% of the family's monthly income, to be assessed at initial enrollment and reassessed at the update of certification or recertification. Current law exempts certain families from those fees. Current law, as of July 1, 2021, transfers those services and responsibility from the State Department of Education to the State Department of Social Services. This bill would, among other things, instead require the family fees to not exceed 1% of the family's monthly income. The bill would require the lead agency to convene a workgroup of, among others, parents, childcare providers, and lead agency staff to develop an equitable fee schedule, as specified.

Summary: Current law requires the State Department of Education to award grants for the establishment of Family Empowerment Centers on Disability in 32 regions in the state to provide training and services to children and young adults with disabilities and their families. Current law establishes a minimum base rate of \$150,000 for each center awarded a grant and requires a center that receives a grant to complete specified actions related to providing that training and those services. Current law establishes a Family Empowerment and Disability Council composed of the executive directors of the centers and certain other members, establishes a base amount of \$150,000 to be made available annually to the council, and requires the council to, among other actions, develop a uniform tracking and data collection system to be used by each center. This bill would revise and recast the provisions related to Family Empowerment Centers on Disability, including requiring the department to award grants by March 1, 2022, to applicants in those of the 32 regions in the state that do not have a center and to give priority to certain applicants, increasing the minimum base rate for each center awarded a grant from \$150,000 to \$246,000 commencing on July 1, 2021, and, commencing with the 2022–23 fiscal year, providing for an annual cost-of-living adjustment of the grant amount, as specified.

Summary: Would reclassify children's crisis residential programs as children's crisis psychiatric residential treatment facilities, and would transfer responsibility for licensing these facilities to the State Department of Health Care Services, contingent upon an appropriation in the annual Budget Act for these purposes. The bill would define "children's crisis psychiatric residential treatment facility" to mean a licensed residential facility operated by a public agency or private organization that provides

the psychiatric services, as prescribed under the Medicaid regulations, to individuals under 21 years of age, in an inpatient setting.

This bill would, contingent upon an appropriation by the Legislature in the annual Budget Act or another statute for these purposes, require the State Department of Education to administer a grant program to provide additional targeted assistance to 10 low-performing school districts with identified opportunity gaps among their pupils, including, but not limited to, opportunity gaps for pupils of color and pupils from low-income backgrounds, to help those school districts close their opportunity gaps. The bill would require those school districts to be competitively selected based on 2018–19 fiscal year data on the California School Dashboard. For the 2021–22, 2022–23, and 2023–24 fiscal years, the bill would require the department to allocate \$1,250,000 to each of the 10 selected school districts to be used to hire and fund one distinguished educator with experience in improving pupil performance and outcomes and to implement a customized action plan to be created by the distinguished educator, as provided.

Summary: Would establish the Parent Participation Preschool Pilot Program, under the administration of the State Department of Education, to provide one-time grants to California state preschool program contracting agencies, as defined, for the creation or expansion of parent participation preschool programs. The bill would define "parent participation preschool program: as a preschool program funded by the state, where there is an educational component for a parent, guardian, or family member of a child in the program, as specified, and there may also be a requirement for those persons to volunteer in the classroom or with other aspects of the program. The bill would require the department to announce and post criteria for grants on or before March 31, 2022, to award grants to selected California state preschool program contracting agencies on or before the beginning of the 2022-23 school year, and to report to the appropriate policy and fiscal committees of the Legislature on the impact of the pilot program on or before January 1, 2024.

Summary: The Medi-Cal program is, in part, governed and funded by federal Medicaid program provisions. Current law imposes requirements on Medi-Cal managed care plans, including standards on network adequacy, alternative access, and minimum loss ratios. This bill would, commencing with the January 1, 2022, rating period, and through December 31, 2024, require the Department of Health Care Services to make incentive payments to qualifying Medi-Cal managed care plans that meet predefined goals and metrics associated with targeted interventions, rendered by school-affiliated behavioral health providers, that increase access to preventive, early intervention, and behavioral health services for children enrolled in kindergarten and grades 1 to 12, inclusive, at those schools.

Analysis of Budget Act of 2021-22 Assembly Bill 167

The Legislature ended its 2021 session this week by sending a flurry of bills to Governor Gavin Newsom. This includes Assembly Bill 167, the budget cleanup bill for K-12 education. The measure will go into effect upon signature by the Governor.

This membership update will review the main changes in AB 167 and offer additional perspectives by CCSESA staff.

Context of this year's budget cleanup bill

The budget trailer bill for education (AB 130, Ch. 44, Stats. 2021) created new programs and reconfigured existing programs, like independent study. At the time, the state was retiring its "Blueprint" in favor of reopening, vaccines were accessible, and we looked forward to a fully inperson school year. In the lead-up to the Budget Act, many lawmakers were preoccupied by whether a pandemic-era virtual learning option should exist at all. The Budget Act of 2021-22 and AB 130 were signed into law on July 9, 2021.

As policymakers evaluated changes and clarifications to their Budget Act, the Delta variant quickly changed the parameters of the discussion. Short-staffed local educational agencies (LEA) were navigating AB 130 implementation, quarantines, contact tracing, and new programs.

AB 167, the Budget Act clean-up bill for education, reflects those changed realities, offering mostly helpful tools to LEAs, particularly around staffing and funding protections. The measure did not, however, modify AB 130's new independent study requirements, given the political pressures and heavily negotiated budget language. Helpful as it is, the clean-up language in AB 167 is not a universal remedy to the challenges being faced by educators, parents, and students this school year.

Below, we discuss the following topics relating to AB 167:

- 1. J-13A: An option for LEAs with COVID-related staff shortages.
- 2. Independent study: Apportionment for guarantine begins day one.
- 3. Independent study: Deadline for written agreements relaxed.
- 4. Independent study: Quarantines at charter schools will not trigger funding determination.
- 5. Independent study: Waivers do not alter the rules of independent study.
- 6. Staffing: Substitute teachers may serve 60 days.
- 7. Staffing: Current CTC flexibilities.
- 8. Expanded Learning Opportunities Program: Grant flexibility.
- 9. Prekindergarten grant program: COE grants amended.
- 10. Model curricula: Contracts to county offices of education.
- 11. Charter schools: Audit deadline delayed.

All statutory references are to the Education Code, as amended in AB 167, or to bill sections within AB 167 if the provision is uncodified budget language.

1. J-13A: An option for LEAs with COVID-related staff shortages.

The Education Code allows the Superintendent of Public Instruction (SPI) to grant apportionment credit to an LEA in cases of school closures due to extraordinary conditions or material decreases in attendance due to emergencies, like fires and floods. (Sections 41422, 46392.) These requests occur through a Form J-13A (Section 46393; see also CDE FAQs).

For **school closures** due to the impacts of Covid-19, AB 167 denies recovery of ADA credit. For **material decreases in attendance** due to the quarantine of pupils pursuant to public health guidance, AB 167 denies recovery of ADA.

Notwithstanding those two sections, the SPI may grant a J-13A request if ALL the following conditions are met (as demonstrated by the appropriate affidavits):

- a. The request is for ADA lost between September 1, 2021, to June 30, 2022.
- b. The school closure or material decrease was due to COVID-19 related staffing shortages.
- c. The LEA is "unable to provide in person instruction due to staffing shortages," certificated or classified employees, "as a result of staff quarantine due to exposure to, or infection with, COVID-19 pursuant to local or state public health guidance."
- d. The LEA has "exhausted all options for obtaining staff coverage and has consulted with their county office of education and the Superintendent [of Public Instruction] in determining that staffing needs cannot be met through any option."
- e. For school closures only, the ADA recovery applies only to "instructional days and minutes that were scheduled for in-person instruction," as demonstrated by a calendar approved by the governing body before the closure.
- f. For school closures only, a state or local public health or safety order required the closure.

(Sections 41422, 46392, 46393.)

Finally, for <u>any</u> J-13A after September 1, 2021, filed for any purpose, the LEA must certify it has "a plan for which independent study will be offered" to any pupil impacted by the school closure or material decrease in attendance within 10 days. (Section 46393(a).) Note: the criterion is for a plan, not implementation of that plan, though the legislative intent is clearly to provide the greatest level of instruction under the circumstances.

As under existing law, independent study provided to a pupil for less than 15 cumulative school days is not required to include tiered reengagement strategies, live instruction and synchronous minimums, and a five-day return to the classroom upon request. (Section 46393(b), exempting the requirements of Section 51747(d)-(f).)

LEAs that have a waiver of the requirement to offer independent study must nevertheless certify their plan to offer independent study for purposes of a J-13A. But they are exempt from the three requirements above. (Section 46393(b).)

2. Independent study: Apportionment for quarantine begins day one.

LEAs may receive apportionment for students participating in independent study because of COVID-19 related quarantine beginning on the first day of quarantine. (Section 51747(a)(6).)

3. Independent study: Deadline for written agreements relaxed.

For the 2021–22 school year only, written agreements must be signed no later than 30 days after the first day of instruction in an independent study program or (as added in AB 167 at Section 51747(g)) by October 15, whichever date comes later. However, it is important to note that all other IS requirements (except as otherwise specified relevant to the duration of IS) must be met upon commencement of instruction.

4. Independent study: Quarantines at charter schools will not trigger funding determination.

Classroom-based charter schools providing independent study to students who are unable to attend classes in person because of a COVID-19-related quarantine are not required to count these students as nonclassroom-based charter school ADA and are not required to file for a funding determination with the State Board of Education. (Section 51747(j).)

5. Independent study: Waivers do not alter the rules of independent study.

AB 130 required all school districts and county offices of education to offer independent study during the 2021-22 school year, unless a waiver was granted by the county superintendent or SPI. (Section 51745.) Nevertheless, the only two ways to generate ADA funding are seat-based instruction or through independent study.

A waiver does not relax any of the Education Code's requirements for independent study. Nor do different rules apply for students on quarantine or "short-term" independent study (less than 15 cumulative school days) based on the LEA's waiver status. To receive ADA funding for non-seat-based instruction, the only option is independent study.

The only exception to this general rule is that an LEA seeking a J-13A is exempt from the requirements of subdivisions (d), (e), and (f) of Section 51747. (Section 46393(b).)

6. Staffing: Substitute teachers may serve 60 days.

For any one assignment, a substitute teacher may serve in a general education, special education, or career technical education assignment for up to 60 cumulative dates. This expires July 1, 2022. (AB 167, Section 47.)

7. Staffing: Current CTC flexibilities.

In an effort to bolster the teaching workforce, the California Commission on Teacher Credentialing (CTC) voted this past week to postpone assessments for Preliminary Credential-RICA, TPA, and CALAPA. More information on these flexibilities, plus waivers of the CBEST and CSET, can be found in the CTC's "Guidance Regarding Actions Related to COVID-19".

8. Expanded Learning Opportunities Program: Grant flexibility.

Grant funds provided to LEAs for the Expanded Learning Opportunities (ELO) Program in the 2021-22 fiscal year may be used to either develop (i.e., plan for) or provide services for an ELO program, and may also roll-over into the 2022-23 fiscal year. (Sections 46120(b)(1) and (d)(7).)

9. Prekindergarten grant program: COE grants amended.

The California Prekindergarten Planning and Implementation Grant Program established, in AB 130, a minimum base grant for each county office of education (COE) equal to 15 percent of the total allocation awarded to each LEA in their county that operates kindergarten programs. This grant is to support countywide planning and capacity building.

AB 167 amended the COE grant amount to \$15,000 per LEA in their county that operates kindergarten programs. LEA is defined as a school district, COE, or charter school. (Section 8281.5(c).)

10. Model curricula: Contracts to county offices of education.

AB 167 requires the CDE to enter contracts with county offices of education or a consortium of county offices for the development of each of the following:

- a. A model curriculum related to the Vietnamese American refugee experience by September 1, 2024. (Section 33540.2.)
- b. A model curriculum related to the Cambodian Genocide by September 1, 2024. (Section 33540.4.)
- c. A model curriculum related to Hmong history and cultural studies by September 1, 2024. (Section 33540.6.)
- d. A model curriculum related to Native American studies by September 1, 2025. (Section 51226.9.)

The model curricula developed pursuant to each of these contracts will be housed on the platform developed and maintained by the California History-Social Science Project.

11. Charter schools: Audit deadline delayed.

AB 167 extends, until January 31, 2022, the deadline for submitting audit and financial reports for the 2020-21 school year to apply to charter schools in addition to other LEAs. (Section 41020(h).)
