

## CCSESA JANUARY 2022

### GENERAL MEMBERSHIP MEETING INFORMATION



**Background:** The California County Superintendents Educational Services Association (CCSESA) provides the organizational mechanism for the 58 County Superintendents of Schools to design and implement statewide programs to identify and promote quality cost-effective educational practices and services, and provide support to school districts in the areas of student services, curriculum and instructional services, fiscal accountability and business services, personnel services, and technology and telecommunications. The 58 convene in person 3 times per year to discuss emerging topics in K-12 education and to share best practices.

Due to COVID-19, the January meeting will be only the second in-person convening of the 58 County Superintendents since the start of the pandemic. In selecting a venue, many factors were considered such as affordability, accommodations for social distancing, airport accessibility and proximity to the ACSA Superintendents' Symposium.
