

#### **Approval of New Contracts for Services**

**<u>Recommendation</u>**: Review and approve the proposed term sheets- three new consulting contracts with the county offices of education in Sacramento, San Diego, and Kern.

#### Background:

Over the past year, CCSESA has resourcefully expanded its capacity to both lead on the membership's policy priorities and develop organizational faculties by engaging in formal and informal agreements for services with county offices of education. Santa Clara (Amanda Dickey) has supported CCSESA's advocacy on pupil mental health, pupil wellness, Medi-Cal/LEC, and early learning. Kern County (Frank Fekete) has supported the Association's legal work. San Bernardino (Dr. Kegham Tashjian) has facilitated the adoption of an evaluation process for the Executive Director.

In the coming year, CCSESA has identified two areas, aligned with our organizational priorities and values, that we believe will require additional capacity.

First, special education will be a defining area of engagement for CCSESA in the coming year. We anticipate the introduction of major policy reforms during the upcoming legislative and budget cycle. Special education financing, policy, and delivery models are uniquely complex. The political backdrop is equally complex. With the consent of Dave Gordon, Sacramento County Superintendent of Schools, **Kristin Wright** has generously agreed to support CCSESA's engagement on special education over the coming year. **See Agreement (1).** As the former CDE Special Education Division Director and current Executive Director of Equity, Prevention and Intervention at Sacramento COE, Ms. Wright brings a wealth of policy, county office, and political experience with respect to this topic.

Second, equity goals continue to encompass all aspects of CCSESA's policy, programmatic, and stakeholder work. Moreover, CCSESA is a committed participant in multiple groups addressing equity within the public education system. These include the Education Coalition's Ad Hoc Committee on Racial Justice and the California Equity Leadership Alliance. Within CCSESA, the Board of Directors approved, and our members have participated in, the Racial Justice Advisory Group, which was established to study the role of county offices of education and local educational agencies in addressing systemic racism within California's public schools.

As the CCSESA Legislative Committee develops positions on bills, we want equity perspectives to remain an important factor. The same goes for policy implementation. Equity plays a key role in the review of LCAPs and corresponding supports for school districts. County offices are playing a growing role in emerging curricular issues, such as Critical Race Theory and Ethnic Studies.

With the agreement of Dr. Mary Barlow, Kern County Superintendent of Schools, Ms. **Krista Herrera**, has agreed to support CCSESA's engagement on educational equity. Ms. Herrera is the Administrator of Professional Learning & Student Support with the Kern County Superintendent of Schools. **See Agreement (2).** 



With the agreement of Dr. Paul Gothold, San Diego County Superintendent of Schools, **Steven A. Dorsey, Ed.D., and Valentin Escanuela, M.Ed,** have agreed to support CCSESA's engagement on educational equity. Within their county office's Equity Department, Dr. Dorsey and Mr. Escanuela are Executive Leadership Coaches. **See Agreement (3).**
