APPROVAL OF BUDGET REQUEST FUNDING FORMULA

Recommendation: Approve the funding proposal associated with the CCSESA budget request relating to

Differentiated Assistance and the Statewide System of Support.

Background:

CCSESA's priority budget request for the Budget Act of 2022 is a dramatic increase in county office funding for Differentiated Assistance and the core operational funding that allow county offices to support their school districts and charter schools within the Statewide System of Support.

Notwithstanding the diversity of county office funding dynamics, this proposal will support all 58 counties at two separate levels. First, every county office will receive more resources for Differentiated Assistance (DA). DA is an add-on grant, which means each county receives the grant on top of any funding to which they are already entitled.

Second, every county office will receive more resources for core operational programs used to support districts. This happens in one of two ways. (A) Two-thirds of counties will receive an increase to their County Operations Grant sufficient to result in a net increase in funding to the COE. (B) The remaining county offices, which would have remained flat-funded for varying periods of time, will receive an ongoing add-on grant equivalent to a cost-of-living adjustment. To pay for these increases, the county office will either receive greater state aid or retain more local property taxes.

Throughout the development of the funding proposal below, CCSESA staff has solicited and integrated the feedback of county superintendents and their staff. Most recently, working groups within the Business and Administration Steering Committee (BASC) offered their expertise to refine the proposals and share data runs. Following the superintendents meeting on April 11, 2022, CCSESA and BASC co-hosted three well-attended collaboration sessions where we refined multiple aspects of the proposal.

What follows is a budget proposal that prioritizes the Statewide System of Support – a role embraced by county superintendents – in a sustainable, fair, and simple distribution across the 58 county offices of education.
