



Strategy Committee Update: Renaming and County Superintendents Academy

Item Type: Discussion/Action

Recommendation: Upon discussion and approval from the Board, the Strategy Committee recommends renaming CCSESA to be known as the “California County Superintendents”.

Background: The strategy committee meets every month to carry out the goals extracted from the year-long strategic plan process and final report. One of the goals in year one is to discuss improving the image and visibility of the organization, of which rebranding CCSESA has been a major component of this goal. To advance the goals from the strategic plan, the committee felt it was important to rebrand before any major work is done, or the equity of associating the work with CCSESA would be lost, as there could be an identity issue if a renaming occurs much later.

The committee was given 7 names, suggested by the committee and CCSESA staff, to vote on. After narrowing it down to two, the committee was unanimous in selecting the recommendation brought forth today. It is important to note that the committee feels strongly about spelling out, and verbally saying all three words in the proposed new name, rather than defaulting to an acronym.

Once the name is approved, the logo redesign process can proceed, to help bring a new visual image to the organization. Another piece to report on (no action required) is the progress of the new County Superintendents Academy that is being led by Ceci Massetti and supported by CCSESA staff. After receiving 40 surveys, CCSESA pulled the data to help determine the next steps for the Academy. Below is the outline of the timeline leading up to a January 2023 launch.

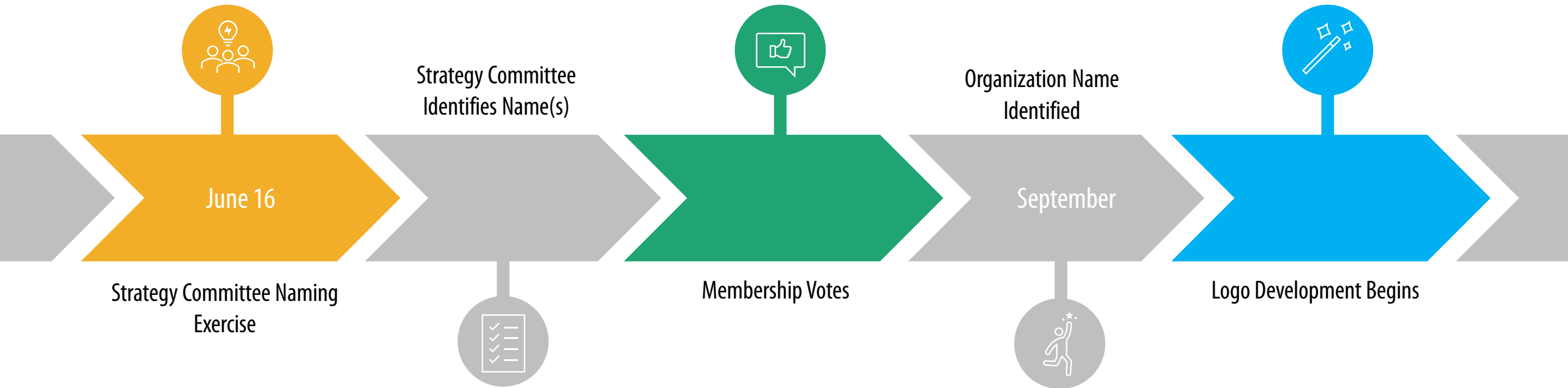

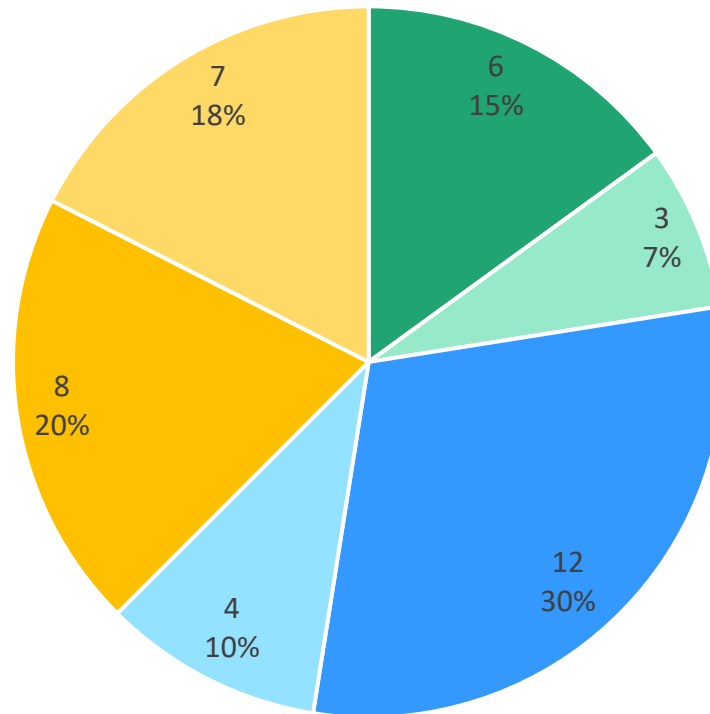

Renaming Process and Timeline



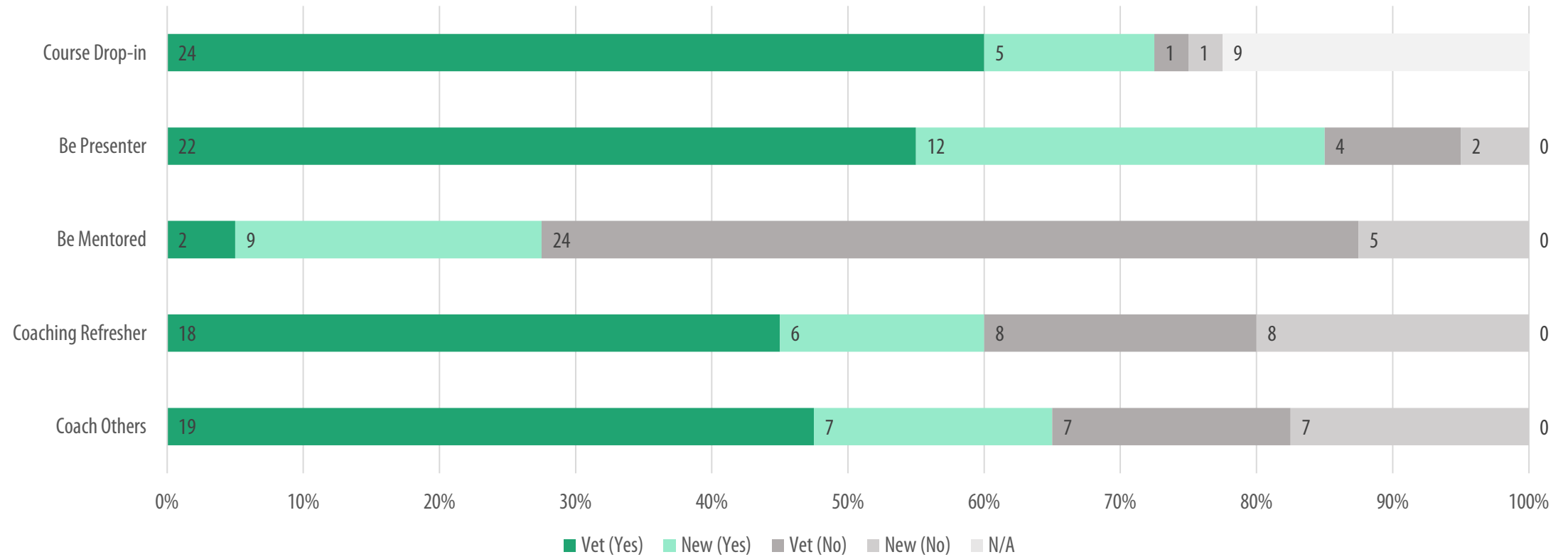
1. Strategy Committee Meets on June 16 to consider new names for CCSESA.
2. Committee agrees on name(s) to bring to the full Membership. If consensus is not reached at the June meeting, this will carry over to the July meeting.
3. At the June GM Meeting or a Monday call, the Membership will vote on the organization's name. CCSESA will be included as an option to measure interest in a new name.
4. The name of the organization is selected by majority vote and should be selected no later than September.
5. Using the organization name as a foundation, the new logo starts development.
