<u>Recommendation</u>: Support of active strategic plan project: the creation of the Superintendent's Academy.

Background: The strategy committee meets every month to carry out the goals extracted from the yearlong strategic plan process and final report. One of the goals in year one is the development of a County Superintendents Academy, which is being led by Ceci Massetti and supported by CCSESA staff.

As part of the development, Ceci, Karen, Kindra and Malia met on August 11th for a full planning day. Using survey data, the planning group developed a draft outline of the Academy structured around the topics the membership identified as most beneficial to someone new to the role of county superintendent. Below is the outline of the timeline leading up to a January 2023 launch.

21CSLA Mid-State Regional Academy Proposal for Coaches' Professional Learning County Superintendents' Academy July 29, 2022

The coaches' professional learning will focus on two books:

- <u>The Coaching Habit</u>, Michael Bungay Stanier, 2016.
- <u>Blended Coaching</u>, Bloom, et al, 2005.

We propose a 2-part professional learning plan as follows:

Part I -

- ✓ Kick-off with a 90-minute virtual session focused on building the habit of questioning.
- ✓ We will discuss different models of coaching (facilitative, instructional, and consultative) and when each is appropriate and most impactful.
- ✓ We will have participants practice multiple types of questioning and coaching with colleagues through the use of scenarios.

Part II –

- A final 90-minute virtual session on combining questioning techniques into an irresistible 1-2-3 combination, developing a robust script for a coaching conversation.
- ✓ We will continue to discuss different models of coaching (collaborative and transformational) and when each is appropriate and most impactful.
- ✓ Participants will continue to practice more types of questioning and coaching with colleagues through the use of scenarios.
