Update: System of Support Leads

Current GeoLead Grant Cycle ends June 30, 2023

- 2022 GeoLead "Request for Renewal" for each of the nine COEs
- Request for Renewal is still pending final approval


SELPA Leads Grant Cycle ends June 30, 2023

- Budget Language was amended to include SELPAs, COEs, or a consortia of SELPAs and COES
- No renewal for the current SELPA leads.
- Adds the following leads (at least one of each):
 - Alternate Dispute Resolution lead,
 - High Quality IEP lead
 - Leads to continue building capacity at the local and regional level.
- CCEE working with CDE to draft RFAs for leads.
- Grant Cycle will be: July 2023 June 2028



Update: 2022 Dashboard: DA Eligibility

- In the absence of 2 years of statewide data, 2022 DA Eligibility will be based on 2021-22 school year data
- Status Levels Only and State Indicators Only
- No College Career Indicator due to limited statewide testing data from 2020-21.
- Simulation using 2019 Data yielded increase from 297 to 399 LEAs identified.

Implications for County Superintendents

- Chronic Absenteeism will count for Differentiated Assistance (2021-22 School Year Data)
 in 2022 Dashboard
- We will see an overwhelming number of LEAs will most likely be identified, many for the first time since 2017
- Charter Schools will become eligible for DA support with the 2023 Dashboard (based on student performance during current school year)
- The 2022 Dashboard will most likely paint a picture that county offices (and districts)
 are not doing enough to support students in California
- How can county offices meet the moment and leverage the 2022 Dashboard
 Release as creating new opportunities for increasing equity and building local capacity to improve outcomes for kids?
