- 2022 is no different!








The Color Purple

2022 State Indicators

Status Only Indicators:

- Academic
- Suspension Rate
- Chronic Absenteeism
- Graduation Rate
- English Learner Progress

No CCI reported on the 2022 Dashboard

- CAASPP testing was limited in 2020-21
- Resumes with "Status Only" reporting on 2023 Dashboard

Changes and Updates to the Dashboard in 2022



Academic Indicator:Federal Participation Rate Penalty

- LEAs/Schools/Student Groups missing the 95% participation requirement means:
 - Assignment of the Lowest Obtainable
 Scale Score (LOSS) for every missing
 score up to 95%
- California updated the penalty in 2020 due to a request from ED



Updated District of Residence Rules

 LEAs that send their Special Education students to schools outside of their district will be held accountable for them across all state indicators

 District of Residence is also called the District of Special Education Accountability

Dashboard Alternative School Status (DASS)

- DASS schools were allowed "modified method" calculations on previous Dashboards for Academic, College/Career and Graduation Rate Indicators
- Starting with the 2022 Dashboard
 - ED: No modified methods allowed within indicator calculations
- CDE will calculate and display the 1-year graduation rate on the Dashboard (will be on the Dashboard in January 2023)



Support Determinations Will Still Use Dashboard Indicators

Every Student Succeeds Act (CSI and ATSI)

How Schools Qualify for CSI/ATSI:

- 1. All Indicators with the lowest status
- 2. All Indicators with the lowest status but one indicator of ANY other status
- 3. Five or More Indicators where a majority are at the lowest status
- 4. All Indicators in the lowest two statuses

Local Control Funding Formula

How LEAs Qualify for Differentiated Assistance:

- One student group in an LEA achieves 2 out of the 3 criteria below:
 - Lowest status for both *ELA* and *Math* or lowest status on *ELPI*
 - Lowest status on graduation rate or lowest status on suspension rate
 - Lowest status on chronic absenteeism


