On behalf of the California County Superintendents Educational Services Association (CCSESA), I am writing to express our strong support for the confirmation of the nominations of Mike Kirst, Carl Cohn and Patricia Rucker to the State Board of Education. All three are currently members of the State Board and all three have served with distinction. The entire education community will be well-served by their re-appointment and confirmation.

As you know, this is a time of extraordinary change in California public education. The State Legislature has approved a major change in school funding, a new emphasis on local transparency and accountability, implementation of the Common Core standards, and a dramatically different student assessment system designed to support instructional improvement.
